## BIG SPRINGS VILLAGE BOARD OF TRUSTEES BUDGET HEARING AND REGULAR MEETING MINUTES September 5, 2023

Roll call: Present Trustees: Van Horn, Dinkel, Farrier, Everitt, and Van Zee. Others present: Village Clerk/Treasurer, Tamera Loomis, Village Attorney Josh Wendell, Village Maintenance, Curtis Brown, and Deuel County Sheriff, Scott DeCoste.

The Budget Hearing of the Village of Big Springs, Deuel County, Nebraska, was called to order at 6:30 p.m. by Chairman Van Zee.

The proposed budget hearing was advertised in the Chappell Register and was posted at the Village Office, U.S. Post Office, and Community First Bank.

Budget presentation outlining key provisions of the proposed budget was presented by Trevor Schuessler, Auditor, Rauner & Associates.

Chairman Van Zee asked for public comments to the budget hearing.

With no public comment forthcoming, a motion was made by Van Zee to adjourn the Budget Hearing, seconded by Van Horn. Yea: Farrier, Everitt, Dinkel, Van Horn and Van Zee. Motion passed unanimously and Budget Hearing adjourned at 6:40pm.

The regular meeting of the Board of Trustees of the Village of Big Springs, Nebraska was called to order at 6:45pm on September 5, 2023 in open and public session by Board Chairman Van Zee. Notice of this meeting was given in advance by posting at the Village Office, U.S. Post Office, and Community First Bank and by publication in the Chappell Register, the Village's designated methods for giving notice, and delivered to members of the Board of Trustees with a copy of their Acknowledgment of Receipt and the Agenda attached to these minutes. Availability of the Agenda was communicated in the advance notice. All proceedings hereafter shown were recorded while said meeting was open to the attendance of the public.

Pledge of Allegiance was recited and a moment of silence was observed.

Chairman Van Zee welcomed the visitors and announced the Open Meeting Law Poster posted on the wall of the meeting room with copies available from the Village Clerk if wanted.

Chairman Van Zee called the Levy Hearing to order at 6:50pm and asked for public comment.

Motion by Farrier, we approve the minutes of the August 1, 2023 meeting, seconded by Everitt. Yea: Farrier, Dinkel, Van Zee, Van Horn, and Everitt. Motion passed unanimously.

Motion by Van Zee, we adopt Resolutions to Rescind R23-09-02 through R23-09-06, seconded by Farrier. Yea: Farrier, Everitt, Dinkel, Van Horn, and Van Zee. Motion passed unanimously.

Motion by Van Zee, we abate 2023 BIG 52 – 601 Chestnut, seconded by Farrier. Yea: Dinkel, Van Horn, Everitt, Farrier, and Van Zee. Motion passed unanimously.

Chairman Van Zee presented and read by title Ordinance No. 23-09-01 – AN ORDINANCE INTRODUCED BY THE GOVERNING BODY CREATING FLOODPLAIN DISTRICTS DEFINING THE SAME AND SETTING FORTH REGULATIONS THEREOF.

Motion by Van Zee, to waive the seconded and third readings of Ordinance No. 23-09-01, seconded by Van Horn. Yea: Van Horn, Farrier, Van Zee, Dinkel, and Everitt. Motion passed unanimously.

Motion by Van Zee, we adopt Ordinance No. 23-09-01, seconded by Farrier. Yea: Farrier, Van Zee, Dinkel, Everitt, and Van Horn. Motion passed unanimously.

Motion by Van Zee, we appoint Dick Huff as the Big Springs Community Floodplain Administrator, seconded by Farrier. Yea: Van Zee, Everitt, Van Horn, Dinkel, and Farrier. Motion passed unanimously.

Chairman Van Zee asked for public comments to the Levy Hearing. With no public comments forthcoming, a motion was made by Van Zee to adjourn the Levy Hearing, seconded by Van Horn. Yea: Everitt, Dinkel, Farrier, Van Zee, and Van Horn. Motion passed unanimously and Levy Hearing adjourned at 7:01pm.

Motion by Van Zee, we adopt Resolution R23-09-01 Setting the 2023-2024 Property Tax Request, seconded by Farrier. Yea: Dinkel, Everitt, Van Zee, Farrier, and Van Horn. Motion passed unanimously.

Brief department reports were heard.

Motion by Van Zee, we pay the 2023-2024 Library budget \$28,450.00 in monthly increments, seconded by Dinkel. Yea: Everitt, Farrier, Van Horn, Van Zee, and Dinkel. Motion passed unanimously.

Motion by Van Zee, we authorize the Chairman Van Zee sign the 2023-2024 Cemetery Interlocal agreement, seconded by Van Horn. Yea: Farrier, Dinkel, Everitt, Van Horn, and Van Zee. Motion passed unanimously.

Motion by Farrier, we request the treasurer contact the Community First Bank and a Public Finance Company for borrowing \$188, 683.00 for Water Meter Install project, seconded by Van Zee. Yea: Dinkel, Farrier, Everitt, Van Zee, and Van Horn. Motion passed unanimously.

Motion by Van Zee, we request the clerk send nuisance letters to 506 Pine ST and 100 E 4<sup>th</sup> ST to clear sidewalks and to 605 Oak ST to remove dead tree from alleyway; letters to be delivered by the Deuel County Sheriff, seconded by Dinkel. Yea: Farrier, Everitt, Van Zee, Dinkel, and Van Horn. Motion passed unanimously.

Motion by Van Zee, we adopt the budget as presented, seconded by Farrier. Yea: Everitt, Van Horn, Farrier, Van Zee, and Dinkel. Motion passed unanimously.

Motion by Van Zee, to set the tax levy at a different amount than the prior year tax request, seconded by Farrier. Yes: Farrier, Everitt, Van Zee, Van Horn, and Van Zee. Motion passed unanimously.

Motion by Van Zee, we pass additional 1% allowable increase to restricted fund authority, seconded by Dinkel. Yea: Farrier, Van Zee, Dinkel, Van Horn, and Everitt. Motion passed unanimously.

Motion by Van Zee, we approve Pilot Travel Centers LLC dba Flying J Travel Center #904, New Manager, Randy E. Dailey, Jr., NE Liquor Control Commission Manager Application Form 103, seconded by Van Horn. Yea: Dinkel, Farrier, Everitt, Van Horn, and Van Zee. Motion passed unanimously.

Motion by Van Zee, we set fall cleanup days to September weekends 16th and 23<sup>th</sup> and make roll-offs available at the maintenance shop, seconded by Van Horn. Yea: Farrier, Van Horn, Dinkel, Van Zee, and Everitt. Motion passed unanimously.

Motion by Van Zee, we approve the claims, seconded by Farrier. Yea: Van Horn, Dinkel, Van Zee, Everitt, and Farrier. Motion passed unanimously.
