BIG SPRINGS VILLAGE BOARD OF TRUSTEES REGULAR MEETING MINUTES October 3, 2023

Present Trustees: Van Horn, Dinkel, Farrier, and Everitt. Absent Trustees: Van Zee. Others present: Village Clerk/Treasurer, Tamera Loomis, Village Maintenance, Curtis Brown, Village Attorney, Josh Wendell, and Deuel County Sheriff Deputy Sean Holloway.

The regular meeting of the Board of Trustees of the Village of Big Springs, Nebraska was called to order at 7:00pm on October 3, 2023 in open and public session by Village Clerk Loomis. Notice of this meeting was given in advance by posting at the Village Office, U.S. Post Office, and Community First Bank and by publication in the Chappell Register and on the Village Official Website + Mobile App at bigspringsne.org, the Village's designated methods for giving notice, and delivered to members of the Board of Trustees with a copy of their Acknowledgment of Receipt and the Agenda attached to these minutes. Availability of the Agenda was communicated in the advance notice. All proceedings hereafter shown were recorded while said meeting was open to the attendance of the public.

Village Clerk Loomis requested nominations from the Village Board for an Acting Board Chairman *pro tempore* to preside over the meeting in absence of the Board Chairman, the Village Board elects one of its members present at the meeting to occupy the position temporarily.

Dinkel nominated Farrier as Acting Board Chairman *pro tempore*. There were no other nominations, nominations closed. Farrier appointed as Acting Board Chairman *pro tempore*. Yea: Farrier, Everitt, Van Horn, and Dinkel. Nomination passed unanimously.

Pledge of Allegiance was recited and a moment of silence was observed.

Acting Chairman Farrier welcomed the visitors and announced the Open Meeting Law Poster posted on the wall of the meeting room with copies available from the Village Clerk if wanted.

Motion by Everitt, we approve the minutes of the September 5, 2023 meeting, seconded by Van Horn. Yea: Van Horn, Farrier, Dinkel, and Everitt. Motion passed unanimously.

Motion by Farrier, we adopt Resolutions to Rescind R23-10-01 and R23-10-02, seconded by Everitt. Yea: Everitt, Dinkel, Farrier, and Van Horn. Motion passed unanimously.

Motion by Farrier, we abate 2023 BIG 36 405 E 4th/PID: 0003145.5, seconded by Dinkel. Yea: Farrier, Van Horn, Everitt, and Dinkel. Motion passed unanimously.

Brief department reports were heard.

Motion by Farrier, we accept the water and sewer rate study provided by Nebraska Rural Water Association (NeRWA) and request the village attorney present the necessary ordinance to repeal all other ordinances and resolutions, and a resolution to adopt new rates at the November 7, 2023 meeting with new rates being effective January 1, 2024 to include annual review, seconded by Van Horn. Yea: Dinkel, Everitt, Farrier, and Van Horn. Motion passed unanimously.

Motion by Farrier, the monthly trash rate be set at residential \$30.00 per month, small commercial \$35.00 per month dumpster dumping 1 time per week, and large commercial \$60.0 per month per dumpster dumping 2 times per week effective January 1, 2024 and we request the village attorney include the trash rates in the same resolution as the water and sewer rates to include annual review, seconded by Dinkel. Yea: Van Horn, Farrier, Everitt, and Dinkel. Motion passed unanimously.

Motion by Farrier, we direct the Village Attorney take the action necessary to move forward with special assessment, for unpaid abatement of nuisance bills at 105 E 4th ST and 407 W 2nd ST, seconded by Dinkel. Yea: Everitt, Dinkel, Van Horn, and Everitt. Motion passed unanimously.

Motion by Farrier, we authorize the Village Board Chairman sign vehicle titles and bill of sale over to Amy's Towing for vehicles and trailer towed from Motion to Abate: 2022 BIG 040 407 W 2nd passed and approved July 5, 2022, seconded by Dinkel. Yea: Farrier, Dinkel, Van Horn, and Everitt. Motion passed unanimously.

Motion by Farrier, we approve the Special Designated Liquor License to Non-Profit Public Service Licensee Big Springs Rural Fire Protection District for Fireman's Annual Bull Fry Fund raiser being held on November 4, 2023 beginning at 5pm in Big Springs, seconded by Dinkel. Yea: Everitt, Van Horn, Farrier, and Dinkel. Motion passed unanimously.

Motion by Farrier, we accept the proposals from Myers Construction for Sewer Lift Station maintenance and cleaning - 4341 \$12,660.00 and 4342 \$9,940.00, seconded by Dinkel. Yea: Van Horn, Farrier, Everitt, and Dinkel. Motion passed unanimously.

Motion by Farrier, we adopt Resolution R23-10-03, Resolution Signing of the Municipal Annual Certification of Program Compliance 2023, seconded by Van Horn. Yea: Dinkel, Everitt, Van Horn, and Farrier. Motion passed unanimously.

Motion by Farrier, we authorize Acting Board Chairman *pro tempore*, Farrier, sign the Municipal Annual Certification of Program Compliance to Nebraska Board of Public Roads Classification and Standards 2023, seconded by Dinkel. Yea: Everitt, Dinkel, Farrier, and Van Horn. Motion passed unanimously.

Motion by Farrier, we approve Clerk and Floodplain Administrator, Dick Huff, attend the Floodplain Administration Workshop in Alliance, NE, October 12, 2023, 8:30am-5pm, seconded by Van Horn. Yea: Dinkel, Farrier, Van Horn, and Everitt. Motion passed unanimously.

Motion by Farrier, we extent the employment period of Part-time Seasonal Maintenance worker, Juan Fraire, to October 31, 2023, seconded by Dinkel. Yea: Dinkel, Van Horn, Everitt, and Farrier. Motion passed unanimously.

Acting Board Chairman *pro tempore*, Farrier, presented and read by title Ordinance No. 23-10-01, AN ORDINANCE OF THE VILLAGE OF BIG SPRINGS, DEUEL COUNTY, NEBRASKA, ESTABLISHING WAGES FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2023, AND ENDING SEPTEMBER 20, 2024, OF THE VILLAGE OF OFFICERS AND EMPLOYEES; REPEALING ALL PRIOR CONFLICTING ORDINANCES AND ORDERING THE PUBLICATION OF THIS ORDINANCE IN PAMPHLET FORM.

Motion by Farrier, we adopt Ordinance No. 23-10-01, seconded by Van Horn. Yea: Dinkel, Farrier, Everitt, and Van Horn. Motion passed unanimously.

Motion by Farrier, the Employer IRA contributions remain unchanged for Curtis Brown \$200.00/mo. and Tamera Loomis \$150.00/mo., seconded by Everitt. Yea: Van Horn, Dinkel, Farrier, and Everitt. Motion passed unanimously.

Motion by Everitt, we approve claims, seconded by Van Horn. Yea: Dinkel, Everitt, Van Horn, and Farrier. Motion passed unanimously.
