## BIG SPRINGS VILLAGE BOARD OF TRUSTEES REGULAR MEETING MINUTES

December 5, 2023

The regular meeting of the Board of Trustees of the Village of Big Springs, Nebraska was called to order at 7:00pm on December 5, 2023 in open and public session by Village Clerk Loomis. Notice of this meeting was given in advance by posting at the Village Office, U.S. Post Office, and Community First Bank and by publication in the Chappell Register and on the Village Official Website + Mobile App at bigspringsne.org, the Village's designated methods for giving notice, and delivered to members of the Board of Trustees with a copy of their Acknowledgment of Receipt and the Agenda attached to these minutes. Availability of the Agenda was communicated in the advance notice. All proceedings hereafter shown were recorded while said meeting was open to the attendance of the public.

Pledge of Allegiance was recited.

Chairman Van Zee welcomed the visitors and announced the Open Meeting Law Poster posted on the wall of the meeting room with copies available from the Village Clerk if wanted.

Motion by Van Zee, we excuse Trustees Van Horn and Farrier, seconded by Dinkel. Yea: Dinkel, Everitt, and Van Zee. Motion passed unanimously.

Motion by Everitt, we approve the minutes of the November 7, 2022 meeting, seconded by Van Zee. Yea: Van Zee, Everitt, and Dinkel. Motion passed unanimously.

Board Reorganization will be on the next regular meeting agenda.

Motion by Van Zee, we appoint Village Officials Jan. 1, 2024 through Dec. 31, 2024: Clerk/Treasurer, Tamera Loomis, Attorney, Josh Wendell, Engineer and Street Superintendent, Tom Werblow, seconded by Dinkel. Yea: Everitt, Van Zee, and Dinkel. Motion passed unanimously.

Motion by Van Zee, we adopt Resolution to Rescind R23-12-01, seconded by Dinkel. Yea: Everitt, Van Zee, and Dinkel. Motion passed unanimously.

Motion by Van Zee, we adopt Resolution R23-12-02 Signing Year-End Certification of City Street Superintendent 2023, seconded by Everitt. Yea: Dinkel, Van Zee, and Everitt. Motion passed unanimously.

## RESOLUTION R22-12-02 Resolution Signing of the Year-End Certification of Village Street Superintendent 2023.

**Whereas:** State of Nebraska Statutes, sections 39-2302, and 39-2511 through 39-2515 details the requirements that must be met in order for a municipality to qualify for an annual Inventive Payment; and

**Whereas:** The State of Nebraska Department of Transportation (NDOT) requires that each incorporated municipality must annually certify (by December 31st of each year) the appointment of the City Street Superintendent to the NDOT using the Year-End Certification of City Street Superintendent; and

Whereas: The NDOT requires that such certification shall also include a copy of the documentation of the city street superintendents appointment, i.e., meeting minutes; showing the appointment of the City Street Superintendent by their name as it appears on their License (if applicable), their License Number and Class of License (if applicable), and type of appointment, i.e., employed, contract (consultant, or interlocal agreement with another incorporated municipality and/or county), and the beginning date of the appointment; and

**Whereas:** The NDOT also requires that such Year-End Certification of City Street Superintendent shall be signed by the Mayor or Village Board Chairperson and shall include a copy a resolution of the governing body authorizing the signing of the Year-End Certification of City Street Superintendent by the Mayor or Village Board Chairperson.

**Be it resolved** that the Village Board Chairperson of the Village of Big Springs is hereby authorized to sign the Year-End Certification of City Street Superintendent.

## RESOLUTION R23-12-03 NUISANCE OFFICER

The Board Chairman and Village Board of Trustees of the Village of Big Springs (hereinafter the Village), in regular session assembled at the Village Office Building in Big Springs, Nebraska on this 5th day of December, 2023 hereby resolve as follows:

**WHEREAS:** The Village desires to appoint a Nuisance Officer pursuant to the Village Revised Municipal Code Chapter 3, Section 3-403.

**WHEREAS:** West Central Nebraska Development District (hereinafter WCNDD) is fully willing, able and qualified to act as Nuisance Office for the Village.

**NOW THEREFORE BE IT RESOLVED** that the Village approves the appointment of WCNDD to act as Nuisance Officer for the Village for a period of twelve (12) months; from January 1, 2024 to December 31, 2024.

**NOW THEREFORE BE IT FURTHER RESOLVED** that the Board Chairman is authorized to sign this resolution, and that any ordinance or resolution in conflict with this Resolution is hereby revoked to any part in conflict herewith.
