## BIG SPRINGS VILLAGE BOARD OF TRUSTEES REGULAR MEETING AND LIQUOR LICENSE HEARING MINUTES

July 11, 2023

Present Trustees: Farrier, Van Horn, and Van Zee. Absent Trustee: Dinkel and Everitt. Others present: Village Clerk/Treasurer, Tamera Loomis, Village Attorney, Josh Wendell, and Deuel County Sheriff Scott DeCoste.

The regular meeting of the Board of Trustees of the Village of Big Springs, Nebraska and the Liquor License Hearing on application of Maverik, Inc. for a Class D Liquor License were called to order at 7:00pm on July 11, 2023 in open and public session by Village Clerk Loomis. Notice of this meeting was given in advance by posting at the Village Office, U.S. Post Office, and Community First Bank and by publication in the Chappell Register and on the Village Official Website + Mobile App at bigspringsne.org, the Village's designated methods for giving notice, and delivered to members of the Board of Trustees with a copy of their Acknowledgment of Receipt and the Agenda attached to these minutes. Availability of the Agenda was communicated in the advance notice. All proceedings hereafter shown were recorded while said meeting was open to the attendance of the public.

Pledge of Allegiance was recited and a moment of silence was observed.

Chairman Van Zee welcomed the visitors and announced the Open Meeting Law Poster posted on the wall of the meeting room with copies available from the Village Clerk if wanted.

Chairman Van Zee asked for comments to give evidence either verbally or by affidavit in support of or in protest against the issuance of Class D Liquor license to Maverik, Inc. dba Maverik, Inc. #715. No comments forthcoming.

Motion by Farrier, we approve the minutes of the June 27, 2023 Show Cause Hearing and Special Meeting, seconded by Van Horn. Yea: Van Zee, Van Horn, and Farrier. Motion passed unanimously.

Chairman Van Zee presented and read by title Ordinance No. 23-05-01, AN ORDINANCE OF THE BIG SPRINGS, DEUEL COUNTY NEBRASKA, TO DESIGNATE A HANDICAPPED PARKING SPOT ON THE EAST SIDE OF PINE STREET ON BLOCK 9 OF THE THOMPSON ADDITION TO BIG SPRINGS; TO REPEAL ALL OTHER ORDINANCES AND RESOLUTIONS, OR PARTS THEREFO IN CONFLICT; AND TO PROVDE WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

Chairman Van Zee presented and read by title Ordinance No. 23-07-01, AN ORDINANCE OF THE VILLAGE OF BIG SPRINGS, DEUEL COUNTY, NEBRASKA, TO ADOPT THE VILLAGE OF BIG SPRINGS ZONING CODE ATTACHED AS EXHIBIT "A"; TO PROVIDE THE EFFECTIVE DATE OF THE BIG SPRINGS ZONING CODE ADOPT WITH THIS ORDINANCE; TO REPEAL ALL OTHER ORDINANCES AND RESOLUTIONS, OR PARTS THEREOF IN CONFLICT; AND TO PROVIDE WHEN THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT.

Motion by Van Zee, we adopt Ordinance No. 23-07-01, seconded by Farrier. Yea: Farrier, Van Horn, and Van Zee. Motion passed unanimously.

Motion by Van Zee, we adopt Resolutions to Rescind R23-07-01 through R23-07-14, seconded by Farrier. Yea: Van Horn, Van Zee, and Farrier. Motion passed unanimously.

Brief department reports were heard.

Motion by Van Zee, we excuse Trustee Everitt due to health issue, seconded by Farrier. Yea: Van Zee, Van Horn, and Farrier. Motion passed unanimously.

Motion by Van Zee, we enter into close session with the board of trustees, the village attorney, the village clerk and Trista Detmer for the purpose of discussing personnel issues and employee performance, seconded by Farrier. Yea: Van Zee, Farrier, and Van Horn. Motion passed unanimously. Close session entered at 7:27p.m.

Motion by Van Zee, we come out of close session at 7:34 p.m., seconded by Van Horn. Yea: Farrier, Van Zee, and Van Horn. Motion passed unanimously.

Motion by Van Zee, we accept the resignation of the Swimming Pool Assistant Manager, Trista Detmer, seconded by Farrier. Yea: Van Zee, Van Horn, and Farrier. Motion passed unanimously.

Brief discussion with the Swimming Pool Manager was held with regard to hiring a replacement for assistant manager or changing the pool days and hours of operation without an assistant manager.

Motion by Farrier, we authorize Board Chairman to work with the pool manager to set days and hours for pool operation without an assistant manager, seconded by Van Horn. Yea: Van Zee, Farrier, and Van Horn. Motion passed unanimously.
