May 14, 2024

The special meeting of the Board of Trustees of the Village of Big Springs, Nebraska was called to order at 7:00pm on May 14, 2024, in open and public session by Chairman Van Zee. Availability of the Agenda was communicated in advance notice. All proceedings hereafter shown were recorded while said meeting was open to the attendance of the public.

Motion by Van Zee we hire Pool Manager, Dashle Richards at \$2,300.00/mo. and Pool Assistant Manager, Zaerihya Doncheske at \$17.00/hr., seconded by Dinkel. Yea: Thompson, Everitt, Dinkel, and Van Zee. Motion passed unanimously.

Motion by Everitt, the Swimming Pool Concessions be in the hands of the Village managed by pool personnel and the Village Clerk/Treasurer, seconded by Van Zee. Yea: Dinkel, Van Zee, Thompson, and Everitt. Motion passed unanimously.

Motion by Van Zee, we approve Curtis Brown's vacation June 3<sup>rd</sup> and July 16<sup>th</sup> through July 19<sup>th</sup>, 2024, seconded by Dinkel. Yea: Everitt, Dinkel, Van Zee, and Thompson. Motion passed unanimously.

Motion by Van Zee, we adjourn, seconded by Everitt. Yea: Dinkel, Thompson, Everitt, and Van Zee. Motion passed unanimously and the meeting adjourned at 7:21pm.
