## BIG SPRINGS VILLAGE BOARD OF TRUSTEES REGULAR MEETING MINUTES

May 7, 2024

Present Trustees: Van Horn, Dinkel, Everitt, and Van Zee. Others present: Village Clerk/Treasurer, Tamera Loomis, Village Maintenance, Curtis Brown, Village Attorney, Josh Wendell, Deuel County Sheriff, Scott DeCoste, and Deputy Sheriff, Sean Holloway.

The regular meeting of the Board of Trustees of the Village of Big Springs, Nebraska was called to order at 7:00pm on May 7, 2024, in open and public session by Chairman Van Zee. Notice of this meeting was given in advance by posting at the Village Office, U.S. Post Office, and Community First Bank and by publication in the Chappell Register and on the Village Official Website + Mobile App at bigspringsne.org, the Village's designated methods for giving notice, and delivered to members of the Board of Trustees with a copy of their Acknowledgment of Receipt and the Agenda attached to these minutes. Availability of the Agenda was communicated in advance notice. All proceedings hereafter shown were recorded while said meeting was open to the attendance of the public.

Pledge of Allegiance was recited.

Chairman Van Zee welcomed the visitors and announced the Open Meeting Law Poster and Meeting Code of Conduct posted on the North wall of the meeting room with copies available from the Village Clerk.

Motion by Everitt, we approve the minutes of the April 16, 2024 meeting, seconded by Dinkel. Yea: Dinkel, Van Zee, Van Horn, and Everitt. Motion passed unanimously.

Chairman Van Zee nominated qualified elector, Tylar Thompson, to the Board of Trustees, to fill the vacancy from the unexpired term – until December 2026, nomination seconded by Van Horn. Roll call: Yea: Everitt, Dinkel, Van Zee, and Van Horn. The nomination passed unanimously.

Brief department reports were heard. Parks and Pool Commissioner, Julia Everitt, thanked Marion & Kathy Peterson and Dave & Konnie Sauder for cleaning out the spring and repairing the bridges. It was reported that the spring had been plugged up again with logs. The Deuel County Sheriff will be on the look-out and will take necessary action to help keep the spring clear. New flooring is being installed in the Depot Museum on Wednesday, May 8th. Volunteers are needed to help move the stove on Wednesday afternoon. Streets: Potholes will be filled once cold mix asphalt is delivered. Treasurer: Donations, \$14,794.16, from the NE/Big Springs Community foundation have been received and expended for the New Park Shelter. One more payment is expected once received and expended the shelter will be picked up from the vendor. The timeline for the destruction of the old shelter and the building of the new shelter is not currently known. All donations and grants pertaining to village property projects are required to be received and expended through the Village Treasurer for transparency and proper documentation to ensure compliance with legal requirements and budgeting.

Clean Harbors and George Packard have been contacted to help remove the liquid tar from AG Valley property. Currently there has been no response from either of them. Follow-up calls will be made.

Viaero Fiber Networks, LLC Construction Plans tabled until next meeting. Request ROW agreement.

Special meeting to be held Tuesday, 05/14/24 at 7pm to consider changing age limits and hiring and setting wages of Swimming Pool Manager and Assistant Manager, revising Swimming Pool handbook, and determine owner/operator of Swimming Pool Concession products purchases and sales.

Motion by Van Zee, we transfer \$1,882.00/mo. from Water fund to the Utility Bond fund for the Go Water Bonds, Series 2024 payments, seconded by Everitt. Yea: Dinkel, Van Horn, Everitt, and Van Zee. Motion passed unanimously.

Motion by Van Zee, we approve payment of the claims, seconded by Everitt. Yea: Dinkel, Everitt, Van Horn, and Van Zee. Motion passed unanimously.
