## BIG SPRINGS VILLAGE BOARD OF TRUSTEES REGULAR MEETING MINUTES

June 4, 2024

Present Trustees: Dinkel, Thompson, Everitt, and Van Zee. Absent: Van Horn. Others present: Village Clerk/Treasurer, Tamera Loomis, Village Maintenance, Curtis Brown, Village Attorney, Josh Wendell, and Deuel County Sheriff, Scott DeCoste.

The regular meeting of the Board of Trustees of the Village of Big Springs, Nebraska was called to order at 7:00pm on June 4, 2024, in open and public session by Chairman Van Zee. Notice of this meeting was given in advance by posting at the Village Office, U.S. Post Office, and Community First Bank and by publication in the Chappell Register and on the Village Official Website + Mobile App at bigspringsne.org, the Village's designated methods for giving notice, and delivered to members of the Board of Trustees with a copy of their Acknowledgment of Receipt and the Agenda attached to these minutes. Availability of the Agenda was communicated in advance notice. All proceedings hereafter shown were recorded while said meeting was open to the attendance of the public.

Pledge of Allegiance was recited.

Chairman Van Zee welcomed the visitors and announced the Open Meeting Law Poster and Meeting Code of Conduct posted on the North wall of the meeting room with copies available from the Village Clerk.

Motion by Everitt, we approve the minutes of the May 13, 2024 meeting, seconded by Van Zee. Yea: Thompson, Everitt, Dinkel, and Van Zee. Motion passed unanimously.

Brief department reports were heard. Maintenance will drag and add sand to the park playground area.

Motion by Van Zee, we get the shades for the Depot Museum, seconded by Dinkel. Yea: Dinkel, Everitt, Van Zee, and Thompson. Motion passed unanimously.

The Trustees considered cleaning up the Veterans Memorial landscaping by replacing the rocked area and dead plants with sod. Measurements will be provided by Maintenance and the Chairman will reach out to companies for sod estimates.

Motion by Van Zee, we adopt Resolutions R24-06-01 through R24-06-16 Declaration of Nuisance Properties, seconded by Everitt. Yea: Everitt, Thompson, Dinkel, and Van Zee. Motion passed unanimously.

Viaero Fiber Networks, LLC, Ron Christensen, President, presented Construction Plans, Julesburg CO to Big Springs DT and Big Springs DT to Big Springs NE, the Trustees will set right-of-way fees and the Village Attorney will create a ROW agreement to be presented to Viaero prior to their beginning construction.

Motion by Van Zee, we authorize Armstrong's and the Big Springs Community Foundation demolish the existing park shelter, we approve the final building plan and concrete work for the new shelter, and we authorize the Village Clerk issue a building permit waiving the fee, seconded by Everitt. Yea: Dinkel, Van Zee, Thompson, and Everitt. Motion passed unanimously.

Motion by Van Zee, we temporarily waive the Placement Of Officers clause from the Interlocal Law Enforcement Cooperation Agreement execute in original duplicate copies on the 6<sup>th</sup> day of June, 2023, seconded by Everitt. Yea: Thompson, Dinkel, Everitt, and Van Zee. Motion passed unanimously.

Motion by Van Zee, we allow E 2<sup>nd</sup> ST (Pine ST to Chestnut ST) to be closed on Sat., June 22<sup>nd</sup> from 12-5pm for the Midsummer Social sponsored by M12 Studio104 E 2<sup>nd</sup> ST, seconded by Everitt. Yea: Dinkel, Everitt, Van Zee, and Thompson. Motion passed unanimously.

Motion by Van Zee, we accept the estimate from Ray's Cement Works to fill the small area at the Village office and we authorize the Village Clerk issue a building permit waiving the fee, seconded by Dinkel. Yea: Thompson, Dinkel, Everitt, and Van Zee. Motion passed unanimously.

Motion by Van Zee, we approve sewer/water loan payment in the amount of \$122,546.25 from the Utility Bond Fund, seconded by Dinkel. Yea: Dinkel, Everitt, Van Zee, and Thompson. Motion passed unanimously.

Motion by Van Zee, we appoint authorized check signers: primary Clerk/Treasurer, Chairman, and Trustee Everitt; alternate Trustee Thompson, 3 signatures required on all checks, seconded by Everitt. Yea: Everitt, Thompson, Dinkel, and Van Zee. Motion passed unanimously.

Motion by Van Zee, we approve payment of the claims, seconded by Everitt. Yea: Van Zee, Thompson, Everitt, and Dinkel. Motion passed unanimously.
