RESOLUTION NO. R25-01-01 APPOINTMENT OF NUISANCE OFFICER

The Board Chairman and Village Board of Trustees of the Village of Big Springs (hereinafter the Village), in regular session assembled at the Village Office Building in Big Springs, Nebraska on this 7^{th} day of January 2025 hereby resolve as follows:

WHEREAS, The Village desires to appoint a Nuisance Officer pursuant to the Village Code of Ordinances Code 254, Section 3-403.

WHEREAS, West Central Nebraska Development District (hereinafter WCNDD) is fully willing, able and qualified to act as Nuisance Officer for the Village.

NOW THEREFORE BE IT RESOLVED that the Village approves the appointment of WCNDD to act as Nuisance Officer for the Village for a period of twelve (12) months; from January 1, 2025 to December 31, 2025.

NOW THEREFORE BE IT FURTHER RESOLVED that the Board Chairman is authorized to sign this resolution, and that any ordinance or resolution in conflict with this Resolution is hereby revoked to any part in conflict herewith.

Everitt moved to have the clerk send a letter to solicit current and previous community members to encourage volunteers to serve on the boards of the Village of Big Springs, seconded by Payne. Yea: Everitt, Huff, Thompson, and Payne. Motion passed.

Huff moved to choose Section 2 for the 2025 Nuisance Abatement area from the three-section Nuisance Abatement area map provided by WCNDD, seconded by Everitt. Yea: Huff, Payne, Thompson, and Everitt. Motion passed.

Huff moved to table the painting of Circle Rd until spring, seconded by Everitt. Yea: Payne, Everitt, Huff, and Thompson. Motion passed.

Everitt moved that the vehicles and traffic violation tickets within the Village of Big Springs limits remain the responsibility of the Deuel County Sheriff's Department to write and the Deuel County Attorney to collect, under state statute, which overrides the municipal ordinance, seconded by Payne. Yea: Huff, Everitt, Payne, and Thompson. Motion passed.

Payne moved to offer utility budget billing to customers beginning October 1, 2025, seconded by Huff. Yea: Everitt, Thompson, Huff, and Payne. Motion passed.

Everitt moved that the clerk request NE Rural Water Association conduct a water and sewer rate study in review of current water and sewer rates, seconded by Thompson. Yea: Payne, Everitt, Huff, and Thompson. Motion passed.

Everitt moved to table making policy to withhold trustees monthly pay for missed meetings, seconded by Payne. Yea: Thompson, Huff, Payne, and Everitt. Motion passed.

Huff moved to proclaim January 2025 Radon Action Month, seconded by Everitt. Yea: Huff, Everitt, Payne, and Thompson. Motion passed.

Huff moved to adjourn, seconded by Everitt. Yea: Payne, Thompson, Everitt, and Huff. Motion passed, and the meeting adjourned at 8:24 PM
